

## The Supercar Event

### Terms and Conditions of passenger participation

#### IMPORTANT NOTICE

**There are risks and dangers associated with riding in a Supercar as a passenger (the Activity), these include personal injury; partial and/or total disability, paralysis or death.** The Supercar Event is organised and managed by The Children's Trust Trading Company Ltd for the benefit of The Children's Trust, together "The Children's Trust". The Children's Trust is committed to safety at all times, however, it is not possible to eliminate all risks.

For your safety, speed restrictions are in place 100mph for adult passengers and 70mph for passengers aged 8-16yrs (these may be reduced based on weather conditions); all drivers possess a full and unrestricted UK driving licence (or other valid, official driving licence where notified) and The Children's Trust is insured for the Activity.

**The Children's Trust are not qualified to express an opinion confirming that you are fit to take part in the Activity and you must ensure that you are fit to take part. You must not take part if you are suffering from any serious medical condition, or have recently undergone surgery unless you have a certificate of your fitness to take part from your doctor. You must not take part if you are pregnant or under the influence of alcohol or drugs.**

The Children's Trust reserves the right to ask proof of age in relation to any passengers, accepted forms of identification are: passports, birth certificates and state issued ID cards only.

The Children's Trust reserves the right to refuse entry to the Activity for any passenger. In such cases the passenger will be entitled to a full refund of the entry fee paid for the Activity.

In the event that you decide not to take part on the day or beforehand you will get a full refund.

#### **The following rules apply to all Passengers taking part in the Activity:**

- All passengers must act responsibly and sensibly at all times.
- All passengers must follow any safety warnings or instructions displayed or given by The Children's Trust, its representatives or the marshals. Passengers must ask if they are unclear about any aspect of the Activity or these rules.
- Passengers must be over the age of 8 years if participating the Supercar ride (which includes Hypercar and Fast Track cars). Children over the age of 8 but under 1.35m will be given a booster seat.
- All passengers over the age of 16 must read these rules and agree to the statements below by signing this document before taking part in the Activity. Parents or guardians are responsible for those under 16 complying with these rules at all times.
- All passengers are required to comply with Health and Safety Requirements and all instructions of marshals. **Drivers will terminate the ride if passengers are not complying with Health and Safety Requirements.** [A full list of Health & Safety Requirements is set out at the end of this document.]

#### **By signing this document you agree:**

- to accept full responsibility for yourself and/or any passenger under the age of 16 who you have made a booking for and give consent for any such passengers under the age of 16 to participate in the Activity.
- to give permission for medical assistance to be administered in the case of accident or emergency to yourself or any passengers under the age of 16 that you have made a booking for that in the absence of any negligence or other breach of duty (including in respect of health and safety) by The Children's Trust you engage in the Activity at your own risk.

**IT IS IMPORTANT THAT YOU READ AND UNDERSTAND THE ABOVE STATEMENTS BEFORE SIGNING. BY SIGNING BELOW YOU ARE AGREEING TO THESE TERMS AND CONDITIONS OF ENGAGING IN THE ACTIVITY.**

- All passengers MUST wear a helmet for the duration of the Activity
- All passengers (aged 12 plus) MUST wear a face covering, unless they are exempt and have an exemption lanyard
- All passengers MUST sanitise their hands before and after the Activity
- Children over the age of 8 but under 1.35m will be given a booster seat
- No children (aged 8-16 years) will be allowed to ride in an open top vehicle
- A temperature check
- All passengers MUST comply with the instructions of marshals

You confirm that you are happy for your name and any footage of you or photographs taken during volunteering at The Supercar Event to be used to publicise The Children’s Trust work, including television broadcasts.
